The Ministry of the Environment of the Czech Republic is taking the opportunity to invite you to a seminar held in Prague – Průhonice on 29 January 2014 aiming at establishing and strengthening bilateral relations between Czech and Norwegian entities active in the field of environmental conservation.

The event is organised under EEA and Norwegian Funds on the occasion of announcement of CZ02 Programme Biodiversity and Ecosystem Services / Environmental Monitoring and Integrated Planning Control / Adaptation to Climate Change. The call of the CZ02 Programme is planned to be announced in the second half of February 2014 for the period of two months.

The aim of the seminar is to help foreign participants introduce their institutions and find suitable partners for co-operation with Czech counterparts, possibly on preparation of partnership projects submitted under the open call of CZ02 Programme. Foreign participants will be offered the chance to introduce their institutions and field of interest for potential cooperation in a 10-minute public speech.

The seminar is held in a partnership of the Ministry of the Environment of the Czech Republic, Norwegian Environment Agency, Ministry of Finance of the Czech Republic and Norwegian Embassy in the Czech Republic.
